BLETSOE OR BLETSHOE.

Blecheshou. - About six miles north-west of Bedford, on the road to Higham The parish boundaries are Riseley and Knotting on the north; Milton Ernest and Radwell on the south; Thurleigh on the east; and Sharnbrook and Felmersham on the west; the river Ouse separates it from the two latter parishes. It comprises the hamlet of Bourne End and part of Whitwick Green. Soil, clay; subsoil, gravel, clay, and limestone.

The area of the parish is probably between 2,100 and 2,200 acres."

The village feast is kept on the first Sunday following September 19.

The lands of Bletsoe were nearly equally divided by the Conqueror between his niece, the Countess Judith, and Hugh de Beauchamp, but the descendants or representatives of the latter eventually acquired almost the entire parish.

Manor. Judith Fee. (The hand of Countess Judith.) In Blacheshou, in the half hundred of Buchelai, Osbernus holds two hides and a-half of the Countess. There is land for four plough-teams. In demesne one plough-hand; and six villans have three plough-lands. There are three bordars, and three servi, and half a mill rated at ten shillings; pasture for one plough-team; pannage for 100 hogs. Worth and hath been worth lx shillings. Leuena, a man of King Edward. held this manor, and could sell or give it away."-Domesday, p. 217.

An interest in this fee passed, presumably, with other estates of the Countess, to the De Greys,2 and was subsequently transferred to the St. Johns or their predecessors in title. Under the superiority of the former family the Harveys held their chief estate in the adjoining parish of Thurleigh. John Hervy, armiger, died seised int. al. of land in "Radeswell" and "Blottesho;" and on or about 14 June, 36 Elizabeth, John Harvye died seised int. al. of a messuage and lands in Bletsoe, worth 10s. 4d. a year, holden of Lord St. John, as of his manor of Bletsoe.4

Bletsoe was the head of a capital honor to which belonged several knight's fees, which are thus enumerated in the Book of Fees, temp. Henry III.:

"In Blechesho, Radwell, Hynewie, Bydeham, Broumham, Chernibroe, Karleton, Turvey, Stachesdon." -Harl. 313, fo. 46.

In the same reign, Simon de Pateshull held this manor of the Barony of Bedford by the service of one knight's fee." This or another Simon is said to have married the daughter and heiress of Robert Bray or Broy, of Bletsoe^b (perhaps a descendant of the Domesday mesne lord).

John (? Simon) de Pateshull held this manor, advowson, &c., of the same barony, but immediately of Roger l'Estrange, and as parcel of Roger de Monchensi's portion thereof. It appears that he enjoyed a several fishery in the Ouse from Stoke to "Humberdale," and fishing rights from Pinch mill to Stoke and from Humberdale to Pavenham (pool).

Simon de Pateshull married Isabella de Steyngreve or Stangrave, a coheir of the Barony of Beauchamp, of Bedford,—see the pedigree under Biddenham, and about the 23rd King Edward I. (1294-5) did homage for the lands which his wife brought him. His widow married, secondly, Sir Walter de Teye, summoned to Parliament 1299-1307, jur. ux., as Walter de Teye, Lord of Stangrave, who died without issue of the said Isabella 1325, seised, in right of his wife, of an interest in Bromham, Wootton, Linslade, Houghton Conquest, and Keysoe,parcel of the said Barony of Bedford, -to which Sir John de Pateshull, knt., son of Simon and Isabella, was found to be heir.

Sir John, who, in 1327, obtained the King's licence for embattling his mansion at Bletsoe, had summons to Parliament as Baron Pateshull, 25 Feb. 1342, but not afterwards; he died in 1349, leaving a son and heir,

Sir William de Pateshull, who died seised of an interest in the Barony of Bedford, &c.; he was never summoned to Parliament, nor can he have been esteemed

About the same time Simon de Pateshull, Adam de Beauchamp, and others were feudatories of the Barony of William de Beauchamp, of Eaton, co. Beds. - Vide Wymington, p. 423, note (b).

A Lord Beauchamp, by his charter, gave the canons of Newenham leave to keep their wild swans on all his waters of Ouze, from the demesne of the barony of Eaton (Socon) to the demesne of the barony of Wahul.

a baron, for his father had but one writ of summons, and there is no proof of sitting. "The Barony of Pateshull," adds Sir Bernard Burke, "must therefore be considered as extinct at the decease of John, Lord Pateshull. William died in 1360, when his estates devolved upon his sisters as coheirs, viz., Alice, married to Thomas Wake of Blisworth; Sybyl, married to Roger de Beauchamp; Mabel, married to Walter de Fauconberg; and Katherine, married to Sir Robert de Tudenham, knt."a

Sybyl, the second-named sister, conveyed the manors of Bletsoe and Keysoe, &c., to her husband, Roger de Beauchamp, who made the former his chief scat, and bequeathed 100l. to the chantry at Bletsoe for maintenance of one priest to sing masses perpetually. In the Dormant and Extinct Peerages, before quoted, we find him described as "one of the eminent warriors of the reign of Edward III., younger son of Giles, and grandson of Walter de Beauchamp, of Alcester, summoned to Parliament as Roger de Bello Campo, Baron Beauchamp of Bletsoe, from 1 June, 1363, to 20 Oct. 1379."

This manor was subsequently transferred by Margaret, heiress of the Beauchamps, great grand-daughter of the above nobleman, to her first husband, Sir Oliver St. John.º This lady married secondly John Beaufort, Duke of Somerset, K.G., by whom she was mother of Lady Margaret Beaufort, said to have been born at Bletsoc, foundress of St. John's and Christ's Colleges at Cambridge, whose son, by her husband, Edward Tudor, Earl of Richmond, ascended the throne as Henry VII. The Duchess of Somerset married thirdly John, Viscount Welles, K.G. The Duchess resided at Bletsoe in great state, as may be collected from the epitaph of Ralph Lancy formerly in this church.d

The manor and eastle of Bletsoe have descended to the present Lord St. John, as shown in the annexed pedigree.

Sir Oliver St. John, who married the heiress of Bletsoe, was a descendant of the ancient family of St. John, of Basing, who were already possessed of large estates in Beds, inherited by a female heir from the Pavelys.

On or about 6th July, 33 Henry VIII., Sir John St. John, knt., obtained a

Inquisition taken at Bedford, 22 May, 1st Elizabeth, on the death of Sir John St. John, who possessed the following property in fee, viz.:

grant of the manor and advowson of Bolnhurst, parcel of the late monastery of Thorney, giving in exchange the manor of "Paulespury," and a consideration in money; he also acquired a close of pasture in Riseley, called Coldham, parcel of Chicksands priory, then lately dissolved.

Sir Oliver St. John, in 1559 created Lord St. John of Bletsoe, was one of the peers who sat in judgment, temp. Elizabeth, upon Thomas, Duke of Norfolk. His lordship's wife, a considerable heiress, was grand-daughter of Sir Michael Fisher."

Lordship, manor, and grange of Cayssho; Coldham pastures in Ryseley and Cayssho parishes; all manorial rights in Cayssho and Little Stoughton, belonging to the lordship, manor, and grange of Cayssho and Coldham aforesaid.

Seised in fee-tail of-

The manor of Blettesho; messuages, &c., in Blettesho, Sharnbroke, Bedford, Berford, Thyrlye, Eton, Radwell in Felmersham, Roxton, and Ryseley, belonging to Blettesho manor; chief manor of Caissho; messuages, &c., in Caissho and Little Stoughton, to the same chief manor of Caissho belonging.

Seised in fee of-

Manor of Lawrence; except 600 acres in Ryseley; had 400 acres of the aforesaid 600 after the death of Anne, Lady St. John, widow, who held them for life; and had the remaining 200 acres after the death of Charles St. John, one of his sons, who held them for life.

The manor and grange of Cayssho, &c., which belonged to Chicksand priory, were held in capite by the twentieth part of a knight's fee; but the jurors do not know how the other property was held. The manor and grange of Cayssho, &c., with Coldham pastures, are valued at 121. per annum; that of Blettesho, &c., are valued at 961. 13s. 73d. per annum. The chief manor of Cayssho, &c., at 801. per annum. The manor of Lawrence (except as before excepted) 41. 15s. 4d. The 400 acres are worth after the death of Lady Anne St. John 201. per annum, but before her death nothing. The other 200 acres are worth after the death of Charles St. John 131. per annum, but during his life nothing.

John St. John died 19 December last past; Oliver St. John, of Blettsho, is son and next heir of John St. John, aged over 30 years at the time of the taking of this Inquisition. Lady Anne St. John, widow, and Charles St. John, aforesuid,

are still surviving at Blettsho.

* By the Inquisition | before referred to under Felmersham (p. 283), taken at Ampthill, 14th Jan. 3 Edward VI., it was found that Sir Michael Fisher, knt., was seised of the manors of Clophall Hall and Kempston, with appurtenances, called flisshers; the manor of Eton called Goldyngton; two messuages, land, and rents, in Eton and Wyboldeston; the manor and advowson of Clyfton,2 together with messuages, lands, and rents in Clyfton, Mepsale, Campton, Stanford, Southiewell, Caldecote, Wrastlyngworth, Hatley Port, Kempston, and Felmersham; lands, meadows, pastures and woods, late in the tenure of the said Michael Fisher, lying in the parish of Clyfton, parcel of the lately dissolved monastery of Chixsondes; the whole of that meadow called Orwell meade, late in the tenure or occupation of Robert Samwell, in Clyfton, parcel of the possessions of the monastery of Wardon, lately dissolved; other premises, woods, rents, and services in the several tenures or occupations of William Tylcok and Alico Nele, situate in Clyfton, also parcel of the said monastery of Wardon. The manor of Clophall Hall and the tenements in Campton were held of the barony of Caynow by fealty and suit, but by whom rendered was unknown, their value being ten marks clear by the year; the manor and premises in Kempston were held of John, Lord Bray, as of his manor of Kempston, by fealty and suit, but for what other service did not appear, and their clear annual value was ten pounds; the manor of Eton and the other premises in Eton and Wyboldeston were holden of Lady Anne Cheyny and Lord Harodon, as of the barony of Eton, but by what service was not known; their clear annual value was six pounds; the tenements, &c, in Felmersham were holden of the Master, Fellows, and Scholars, of the Holy Trinity in Cambridge as of their manor of Felmersham, by what service not known, and their clear annual value was nine pounds and five shillings; the premises in Caldecote were held of John Barnardiston as of his manor of Ikwellbury, but it was not known by what service, and their clear yearly value was thirty shillings; the manor and advowson of Clyston, together with all the other lands and tenements in Clyfton and Mepsale, except those pertaining to the said late monasteries of Chixsondes and Wordon, were lately held of William, Bishop of Lincoln, as of his manor of Biggleswade, by fealty and suit, and for a certain rent, their net value 40 marks; the premises, parcel of the said dissolved monastery of Chixsondes, worth ten shillings a year, were held of the Crown in socage, of the honor of Ewe Elme, in the county of Oxford, by fealty only; the said meadow called Orwell meade and all the other premises in Clyfton, parcel of the late monastery of Wardon, worth 20s. per annum, were held of the Queen in free socage as of her manor of Exworth, co Lincoln, and not in capite, and for a crown rent of 2s. paid annually into the Court of Augmentation at the feast of St. Michael; the messuage, &c.

From Thomas, their younger son, descended Sir Oliver St. John, Lord Chief Justice of the Common Pleas, temp. Charles I., and afterwards ambassador to Holland under the Commonwealth. A memoir of the Chief Justice will be found in vol vi. of Foss's Judges of England, which also contains a short notice of the first Earl of Bolingbroke.

On or about 2 April, 28 Elizabeth, John, 2nd Lord St. John, obtained the Queen's licence to alienate the manors of Bolnhurst, Stanfordbury, Keysoe grange, and other hereditaments, to Sir Thomas Bromley, knt., Lord Chancellor of England, Henry, Earl of Kent, George, Earl of Cumberland, Lewis, Lord Mordaunt, Sir William Russell, knt., and others. This nobleman was one of the peers who sat on the trial of Mary, Queen of Scots. He died without male issue surviving, when the title passed to his lordship's brother,

Oliver, third Baron, who had, with other issue, Oliver, his successor, and

Rowland, progenitor of the present Lord St. John.

Oliver, 4th Baron, was, in 1624, advanced to the title of Earl of Bolingbroke. His elder son, Oliver, Lord St. John, summoned to Parliament, by writ, in the Earl's lifetime, achieved an unenviable notoriety; his character is portrayed by Clarendon. The earldom became extinct in 1711, when the barony devolved to the posterity of Sir Rowland St. John, above mentioned, a younger son of Oliver, the 3rd Lord.

John, 10th Baron St. John, and his eldest son and heir, were parties to a deed of bargain and sale, dated 29 Nov. 1755, dealing with the manors and advowin Wrastlyngworth and Hatley Port (except 100 acres, holden of John Burgoyn, as of his manor of Sutton, by fealty, suit, and 5s. rent, and worth 30s. a year) were held of the Crown as of the manor of Wrastlyngworth, in socage, by fealty and suit and for a certain rent, and were worth 201. a year; the tenements in Stamford and Southill, worth 40s. per amnum, were held of the Crown as of the manor of Stamford, late parcel of the monastery of Wardon, in socage, by fealty, suit, and a certain rent. The said Michael ffissher died the 18th June then last past, and Agnes, wife of Oliver Scynt John, armiger, was his next heir, viz., daughter and heiress of John flissher, armiger, deceased, son and heir apparent whilst he lived of the said Sir Michael flissher, knt., and she was then aged 22 years and upwards.

In Trinity term, 16 Charles I., a fine was levied between Christiana Harvey, widow, and Sir William Fleetwood, knt., and Elizabeth, his wife, querents, and Oliver, Earl of Bolingbroke, and Elizabeth, his wife, deforciants, of the manor of Boluhurst, and of premises, &c., with appurtenances in Boluhurst, Pertenhall, and Husborne Crawley; also of the advowson of the church of Bolnhurst, and of two parts of all the tithes of corn and grain arising annually in Bolnhurst.

In Hilary term, 1649, a fine passed between Sir Beauchamp St. John, knt., and Oliver St. John, armiger, querents, and Anthony St. John, armiger, and Anne, his wife, deforciants, of the rectory of Thurleigh alias Thurley, with appurtenances, in co. Bedford.

sons of Bletsoe and Riseley, the rectory of the latter, premises in Melchbourne and Sharnbrook, Stoke Mill "in Bletsoe and Sharnbrook or one of them," &c."

St. Andrew, 13th Baron, grandfather and namesake of the present peer, born in August, 1759, was educated at Christ Church, Oxford, and became a D.C.L. 1795. He was also called to the Bar, and represented this county for 25 years, till 1805, when he succeeded to the title. He was firmly attached to the political opinions of Mr. Fox, with whom he passed much of his time, and who was a great friend of his. His lordship died in 1817, and was buried in the vault at Bletsoe.b

The mansion house of Bletsoe Castle, built originally in form of a quadrangle, entered from the south, stands at a small distance from the church to the north. Only the north side remains, occupied by a farmer, but retaining no internal marks of ancient grandeur except at the east end, where there is an ascent by a spacious stairease to the upper rooms. This side was built of brick; and we may The piers of the gate presume the whole house was built of the same material. and bridge over the moat, now filled up, remain in front.° Fisher gives a view of Bletsoe Castle, and of the old bridge over the moat.

The Lords of Bletsoe frequently entertained Royalty at this once hospitable mansion, as we learn from the following, taken from Nichols's Royal Progresses,

Queen Elizabeth, in 1578, returned from Suffolk by Cambridge. Her Majesty rested at the following noblemen's and gentlemen's scats:-Mr. Hyndes', Madingley,-The Bishop of Ely's, Somersham, -Sir Henry Cromwell's, Ramsey Abbey, -Justice Dyer's, probably at Great Staughton, -Lord St. John's, at "Melchborne" (? Bletsoe); and so through Bucks towards Windsor .- Vol. ii. p. 109.

King James I. visited Bletsoe Castle no less than six times, and his Queen once:

1605, July 26. To Dunstable, to Mr. Sandy's, for the King, and to Sir J. Rotheram's, near Luton, for the Queen, 1 night.

- July 27. To Ampthill, to Sir Richard Conquest's, for the King, and to Sir Robert Newdigate's, for the Queen, 5 nights-9 miles.

In 1825, Sir Robert Inglis, Bart., purchased a farm at Bourne End, Bletsoe, of the annual value of between 2001. and 3001., from the representatives of Mr. Gell. (MS. Marsh.)

CHARITIES.ª

From the abstract of Returns of Charitable Donations for Benefit of Poor Persons, printed 26 June, 1816, it appears that there were two small charities, rent of land, in this parish left by persons unknown. One, then producing 1l. per annum, vested in the Rector and Overseers, was given for the poor (1687). The other, vested in Vestrymen, and producing 3l. 10s. a year, was applied to the wants of poor persons not receiving parish relief.

The Parliamentary Gazetteer, 1847, gives the Charities as amounting to 12l. 10s. per annum. According to Lewis's Topographical Dictionary, 1848, a bequest of 8l. per annum was applied to the support of a Sunday school.

RECTORY' AND ADVOWSON.

The advowson is appendant to the manor.

At the Taxation of Pope Nicholas, 1291, the rectory was rated at 8l. 13s. 4d.;

b The following is from a Terrier, made in 1822: A true note and description of all the globes, lands, meadows, tenements, and other rights belonging to the rectory and parish church of Bletsoe, in the county of Bedford and diocese of Lincoln, now in the use and possession of John Lecte, clerk, rector of the said church, taken and made, according to the old evidences of the antient inhabitants, this 1st day of July, in the year 1822, and exhibited at the Visitation of the Honourable and Right Reverend Father in God, George, Lord Bishop of Lincoln, at his Visitation, held at Bedford, in the said county and diocese aforesaid, the fifth day of July in the same year.

Imprinis, one dwelling-house, part stone built and part mud and studd, part thatched and part tiled. In length about 68 feet, in breadth about 23 feet within the walls; attached thereto is a stone-built and thatched kitchen and dairy, in length about 47 feet, in breadth about 17 feet, within the walls; which said kitchen and dairy were formerly ruinous out offices, and have been converted to the convenient state they are now in by the present rector, who has also much improved the house and premises at considerable expense. One thatched building, in length about 70 feet, in breadth about 15 feet, within the walls, part stone-built and part studd and boarded, divided into a stable, barn, and other offices.

Item, the churchyard, containing three roods or thereabouts, surrounded by the common green, belonging to the Lord of the Manor, upon which green stand some cottages adjoining the churchyard on the south-west; the other parts of the churchyard is fenced with a stone wall, which, together with the gates, are kept in repair by the parish.

Item, the rectory gardens and homestead, together with an antient inclosure called the Upper Glebe, containing in the whole 5a. 2a. 26r. adjoining Lord St. John on the north and west, Lord St. John on the south, and the highways on the east.

Item, an antient enclosure called the Great Glebe, containing 284. 3n. Or., adjoining the Upper Glebe on the east, to Lord Saint John on the north and north-east, to the turnpike road on the west, to Dr. and Mrs. Queen on the south.

Item, four doles of meadow land lying dispersed in four several slips in town meadow, and containing together 1A. 2R. 34P. The whole of which lands, containing together 36A. OR. 20P., or thereabouts, are situate within the lordship and manor of Bletsee, free from the payment of any fines, rents, or services to any chief lord, the royalty of which said lands are also in the rector.

Item, also belonging to the said rectory is an inclosure lying in the adjoining parish of Sharnbrook, 0A. 3n. 0r. The glebe lands and profits of the rectory are worth (at the present) about 2951. per annum. The rector also considers himself entitled to the tythe of about four acres of land lying upon the border of the adjoining parish of Sharnbrook, near Stoke Mills, belonging to Mr. King, and called and known by the name of Crowland Meadow, which said land, not being awarded to the parish of Sharnbrook at the time of the inclosure, is supposed to belong to this parish, and which said tythe the rector is considered by antient and well-informed persons to be cutified to.

Belonging to the said rectory is an oblation of 6d. at every churching of women, for every marriage by banus, 3s. 6d., by licence, 5s., mortuaries, 10s.

There is also due to the parish clerk at every churching of women, two pence, for every marriage by hanns, 2s., by licence, 2s 6d, for every funeral for every corpse brought into the parish to be interred, 6s. 8d. In the churchyard, including tolling the bell and making the grave, 2s. 6d., for every funeral in the church, 5s., for every corpse brought into the parish

Belonging to the said parish are, first, the parish church, an antient building containing in length 54 feet, in breadth 25 feet, within the walls; the for interment, 5s. chancel, which is divided from the body of the church by the belfry, contains in breadth 16 feet, in length 40 feet, within the walls; the steeple about 13 feet square, in height about 54 feet.

Within and belonging to which are one communion table with a handsome covering of green cloth fringed with silk, one linen cloth, one napkin, oz. One chest with four locks containing the parish accounts. One pulpit and reading desk. One pulpit cushion and hanging cloth. One hanging cloth for desk, each made of green cloth, and ornamented with silk tassels and fringe. One large Bible of the last translation. Three Common Prayer Books. The King's arms. The Apostles' Creed. The Lord's Prayer, and the Ten Commandments. One bier. One hearse cloth. One surplice. One Church clock. Five bells with their frames, the first or least bell being 2 feet 7} inches in diameter, with an inscription as follows: viz.

"I mean to make it understood, Altho' I'm little, yet I'm good."

The second, 2 feet 91 inches in diameter, with an inscription -

"While we do Join in cheerful sound,

Let love and loyalty abound."

On each bell, " Jno. Coles, Nicholas King, Churchwardens, 1786."

The third, 2 feet 111 inches, with an inscription-

"Ye people all that hear us ring. Be faithful to your God and King."

The fourth, 3 feet 2 inches, with an inscription-

" I to the poor and needy am a friend, For whose relief I call you to attend."

The fifth, or largest bell, 3 feet 64 inches in diameter, with an inscription-

"I to the Church the living call, And to the grave I summon all."

There are a few private pews in the church, but most of which, together with the common seats, are kept in repair at the expense of the

To the said church belongs a cottage and garden, at present in the occupation of the parish clerk, at the yearly rent of 30s., in length 105 feet, parish. in width 60 feet, adjoining the public highway, (Lord) Saint John on the east, north, and west. To the said church also belongs a slicep common, in the said parish, let at the yearly rent of ten shillings. There is also belonging to the said church an inclosure in the parish of Riscley, containing one acro or thereabouts, let on an average at about 31 a year, the rents of which said cottage, common, and inclosure, amounting in the whole to about five pounds a year, are faithfully applied by the churchwardens towards keeping the said church in good and sufficient repair. There is also belonging to the said church a coltage adjoining the churchyard on the south-west, of the yearly value of about 20s., which is at present occupied by old and infirm people, who the churchwardens permit to live rent free.



With the exception of one or two minor features, the style of architecture of the parish church is mostly Decorated. It is a cruciform church, without aisles, a tower in the centre, a south porch, and is dedicated to St. Mary. Attached to the church is the vault of the St. John family, over which a former Baron erected the present north chapel, or transept, which contains the family monuments; half the vault is bricked up, being full.

The whole structure underwent restoration about the year 1868, at a cost of upwards of 1,700*l*.⁶

The roofs are modern but good, particularly those over the north transcpt and chancel. The pulpit, lectern, and reading pew are also well carved; on the first are the words "Preach the Word, exhort with all long-suffering and doctrine."

All the windows in the nave are pointed and of three lights each, with the exception of a small rose-light above the west window.

About the year 1258, Nicholas de Sarnebroe was appointed chauntry priest in the chapel of St. Mary, Bletsoe, by Sir de Pateshull, knt.—Lincoln Register.

Near the north door is a stoup, and remains of a fresco on the wall, in which a knight on horseback, on a field of battle, is represented. A pointed doorway which led to the rood-stairs has been blocked up; it is near the north-east angle of the nave. Above the western or nave tower-arch was a square-headed doorway; the same arch carries a dripstone on the west. The font, octagonal panelled, stands on an octagon shaft. There was formerly a gallery at the west end of the church.

All the windows which light the north transept are pointed. Besides the monuments above-mentioned, this transept contains a double trefoiled piscina.

The eastern window of the south transept is square-headed, the southern pointed. The side windows of the chancel, which are all square-headed, and the east window, which is pointed, are filled with Decorated tracery.

The principals of the chancel-roof spring from eight corbels. A lancet-opening faces east from the ringing chamber. In the south wall is a low side window, now built up.

The chancel contains two low arched or pointed recesses, one in the north wall and one in the south; the former of these is plain, but having the outside mouldings crocketed; the latter, cinqfoiled, has a dripstone springing from two corbelheads. There is also a pointed triple sedilia, with graduated seats, and a piscina, with a dripstone, embracing all, springing from two corbel heads.

MONUMENTS AND INSCRIPTIONS.

North Transept.

Of the St. John monuments, the first on the south wall of the north transept is a beautiful well-preserved group of alabaster figures, representing an old man kneeling, bare headed, divided beard; five sons, one with a beard, whiskers, a cape, and armour; another in beard and ruff; two smaller in armour; a boy in a coat, with a scull at his feet. The lady is in a close cap and ruff, long sleeves

In Bletsoe church was a Latin epitaph, now gone, for Ralph Launcy; he died 18 Aug. 1458, and is styled cofferer and keeper of the wardrobe to the most noble Margaret, Duchess of Somerset, then married to her third husband, Leo, Lord Welles.—Lysons.

Arms: Quarterly 1 and 4, A crescent between three 2 and 3, Three lions rampant.

fastened with tapes, and gilt embroidered cuffs; four daughters behind her, one wringing her hands. This is the monument of Sir John St. John, who married firstly Margaret Waldegrave, and was father of Oliver, first Baron, whom he lived to see created a peer.

The word matertera in the epitaph must be understood to mean great aunt. The inscription cannot apply to the father of this Sir John, who was properly speaking nephew of Margaret, Countess of Richmond. It appears by the following inscription that the Countess of Richmond brought him up with her grandson Henry VIII., who made him guardian of his daughters, the Princesses Mary and Elizabeth, and that he died in the office of Chamberlain to the latter when Queen.

The said Lady Frances Cavendyshe Countess of Bolingbrooke died on the Assumption of our Lady the 15th of August 1678 having lived with her said Husband 23 years 8 months and one day to his great comfort.

She was the daughter of the Revd John Middleton Scott, of Ballygannon, in the County of Wicklow, Ireland, and the Lady Arabella Brabazon his wife. She died at Bletsoe on the xxvith day of January MDCCCXXXVII. Leaving an afflicted Husband and two infant children to bewail the loss of one of the best of Wives and most affectionate of Mothers.

Sacred to the Memory of John Bithrey, who departed this life on the XXVIII Day of October, MDCCCXLVI. Aged xen years. Also of Susannah, Relict of the above John Bithrey, who died on the xn of December MDCCCXLVI., aged LXXXIII years.
